- 2) Finance Report Monthly Financial Statements as of December 31, 2023
 - a) Balance Sheet = \$17,634,899
 - b) Cash Flow Projections =
 - Start with 8.3 million cash on hand, currently has an estimated 12 million; surplus is due to grant funding from the previous year. The plan is to maintain this cash flow until the end of the schol year
 - c) Profit & Loss Budget VS. Actual = net surplus of \$2,537,148
 - i) SF = \$939, 744
 - ii) VDLE = \$983,953
 - iii) Reed = \$335,638
 - iv) EMS = \$277,813
 - d) Yearly Comparison SY 24 vs SY 23
 - i) Slight increase of revenues and expenses compared to last year due to receiving additional funding from NOLA-PS, which was not originally estimated.
 - ii) Compared to SY 23 (revenue in February was 49%; Feb. 2024, revenue is at 46%. Expenses were at 55% for SY 23; Currently at 54% for February 2024 our revenue remaining in February .
 - iii) Fundraising = \$6,820
 - e) Student Activity = \$127,149
 - i) VDLE =\$25,189.63
 - ii) STR = \$40,021.82
 - iii) EMS = \$29,853.73
