# **Academic Committee:**

- 1. No new data to share due to testing.
  - a. LasLinks results will be available late May; LEAP testing results will be available between late June and early July
- 2. Board Support of University Partnerships
  - a. A one pager was created to analyze how partnerships are being utilized
    - i. Questions around funding and high school college credit opportunities
- 3. Insight Survey Updates: 90% responses from teachers. Data will be finalized by May 31, 2022

#### **Finance Committee**

  - b. NOLA-PA expects increase in funding per pupil
  - c. Budget Louisiana mandates an increase in teacher pay. Increase will be \$1500 for teachers and \$750 for teachers

  - a. View of staffing and retention
  - b. Questions about Einstein's approach to increase teacher recruitment after seeing the decline in teachers...
    - i. Response: increasing salaries to help retain and attract; retention incentives that will be given throughout the year
  - c. Student Attendance shows increase
  - d. Health and Safety
    - i. Staff vaccination rate- 94%
    - ii. Student and Staff Quarentines = 0 students; 0 staff
