 - a) Presentation of Network Instructional Expectations and ECS Instructional Tights
 - i) All teachers will utilize Scope and Sequence, Curriculum Maps and Pacing Guides
 - ii) All teachers administer network common benchmark assessments in ELA and Math
 - iii) All teachers will utilize standards-based instruction
